Williams 2006 Trust ("GW Trust") acquired 7,938 shares of common stock on July 18, 2018 and 3,442 shares on July 19, 2018. Purchases were made pursuant to 10b5-1 Plan dated June 14, 2018. Mr. Williams is a trustee of both trusts.
- Represents the weighted average price for the shares. The shares were purchased at prices ranging from \$1.70 per share to \$1.75 per share. LLC, whose manager is Mr. Williams, (iii) 4,358,082 shares of common stock owned by Sam Williams Family Investments LLC, whose manager is Mr. Williams, and (iv) 5,092,743 shares of common stock owned by GST.
