Williams 2006 Trust ("GW Trust") acquired 3,410 shares of common stock on June 14, 2019 and 3,553 shares on June 17, 2019. Purchases were made pursuant to 10b5-1 Plan dated March 1, 2019. Mr. Williams is a trustee of both trusts.
