**Explanation of Responses:**

- Sam B Williams 95 GST Trust ("GST") acquired 7,937 shares of common stock on September 18, 2018 and 6,871 shares on September 19, 2018. The Gregg G. Williams 2006 Trust ("GW Trust") acquired 7,938 shares of common stock on September 18, 2018 and 6,870 shares on September 19, 2018. Purchases were made pursuant to a 10b5-1 plan dated June 14, 2018. Mr. Williams is a trustee of both trusts.
- Represents the weighted average price for the shares. The shares were purchased at prices ranging from \$1.81 per share to \$1.92 per share. LLC, whose manager is Mr. Williams, (iii) 4,358,082 shares of common stock owned by Sam Williams Family Investments LLC, whose manager is Mr. Williams, and (iv) 6,942,169 shares of common stock owned by GST.
