Williams 2006 Trust ("GW Trust") acquired 7,938 shares of common stock on September 6, 2018 and 7,937 shares on September 7, 2018. Purchases were made pursuant to a 10b5-1 plan dated June 14, 2018. Mr. Williams is a trustee of both trusts.
- Represents the weighted average price for the shares. The shares were purchased at prices ranging from \$1.69 per share to \$1.79 per share.
